***Tribal Law & Order Act “25 CFR 11.104” Tribal Government law The Tribal Law and Order Act of 2010 is a law, signed into effect by President Barack Obama, that expands the punitive abilities of tribal courts across the nation. The law allows tribal courts operating in Indian country to increase jail sentences handed down in criminal cases over Indian offenders. This was a major step toward improving enforcement and justice in Indian country—and a precursor to VAWA 2013.***

***The purposes of the Tribal Law and Order Act are to:***

- ***Clarify the responsibilities of the federal, state, tribal, and local governments with respect to crimes in Indian Country;***
- ***Increase coordination and communication among federal, state, tribal, and local law enforcement agencies;***
- ***Empower tribal governments with the authority, resources, and information necessary to safely and effectively provide public safety in Indian Country.***
- ***ILOC Report: A Road map For Making Native America Safer, The Indian Law and Order Commission released its final report and recommendations—A Road map For Making Native America Safer—as required by the Tribal Law and Order Act of 2010. These recommendations are intended to make Native American and Alaska Native nations safer and more just for all U.S. citizens and to reduce the unacceptably high rates of violent crime that have plagued Indian country for decades. This report reflects one of the most comprehensive assessments ever undertaken of criminal justice systems servicing applicability Federal Contractor Policies P.L. 93-638 Contracts “25 CFR PART 900” 107(a)***

**A. Contractor Policies Final Rule will apply this tribal consultation policy to all proposed policies that have tribal implications, to the greatest extent practicable and permitted by law. Based on a government-to-government relationship and in recognition of the uniqueness of each tribe, the**

**primary focus for consultation activities is with individual tribes. The federal Contractor may serve, under the direction of the United States Of America, as the lead US Agency Tribal Nations Indian Self-Determination and Education Assistance Contracting and Consulting officer for the implementation of this policy. Section 107 Contractor policies and procedures are from this policy Self-Determination Education Act and Energy Self Determination Act 25 CFR Part 900 Congressional Act Final Rule**

**B. Comment: Policy Must Address Confidentiality of Tribal Interests. One commented, citing Pueblo of Sandia v United States, 50 F.3d 856, 861-62 (10th Cir. 1995), stated that it is critical to engage in tribal consultation in a manner that exhibits sensitivity to and respect for tribal confidentiality concerns regarding cultural, religious, political, and other inter-tribal affairs.**

**C. Executive Order 13175 (65 FR 67249, published November 9, 2000) recognizes the right of Indian tribes to self-government and supports tribal sovereignty and self-determination. Among other things, it requires that agencies have an accountable process to ensure meaningful and timely input by tribal officials in developing policies that have tribal implications. On November 5, 2009, President Obama reaffirmed the M-10-33 government-to-government relationship between the Federal Government and Indian tribal governments in a White House memorandum that acknowledges that Indian tribes exercise inherent sovereign powers over their members and territory. The November 5, 2009, memorandum also acknowledged that the United States would continue to work with Indian tribes on a government-to-government basis to address issues concerning Indian tribal self-government, tribal trust resources, and Indian tribal treaty and other rights.**

## 1.1. Tribe

**“Tribe”** means the tribe of the Tribal Nations Federal Land Management of Mendocino Indian Reservation, its departments, programs, entities and subdivisions operating under a governing document established pursuant to authority contained in the Tribal Government Constitution.

## 1.2. Council

**“Council”** means the Tribal Government Federal Land Management of Mendocino Indian Reservation Tribal Council as established by the Tribal Government Constitution.

## 1.3. Tribal Entity

**“Tribal Entity” or “Tribal operations” means the Tribal Government itself**, its departments, programs, entities and subdivisions operating under a governing document established pursuant to authority contained in the Tribal Government Constitution.



# Constitution

## 1.4. CONSTITUTION OF THE TRIBAL NATIONS FEDERAL LAND MANAGEMENT OF MENDOCINO INDIAN RESERVATION

***We the Native people (Community) of the Tribal Nations Tribe, a federally recognized sovereign do hereby adopt this constitution in order to: Promote the common good and well-being of the Tribal Government; Protect and preserve our culture and traditions including our language, arts and crafts, and archaeological sites; Protect our land, water and natural resources; Promote and protect the health and welfare of our people; Encourage and promote educational opportunities for members ; Foster economic development; Protect the individual rights of our members; Acquire additional lands for the benefit of the Tribal Government; Promote self-government and ensure the political integrity of the members; Preserve, secure and exercise all the inherent sovereign rights and powers of Chief Head***

### ARTICLE I - TERRITORY AND JURISDICTION

## **1.4.1. ARTICLE II- TERRITORY**

### **1.4.1.1. Section 1. Territory.**

***The territory of the Tribal Government shall include, to the fullest extent possible consistent with Tribal Government federal law, all lands, water, property, airspace, surface rights, and other natural resources in which now or in the future has any interest, which are owned now or in the future by Tribal Government for the exclusive or non-exclusive benefit of the members, or which are located within the boundaries of a reservation which may be established for the Tribal Government.***

### **1.4.1.2. Section 2. Jurisdiction.**

***by federal law, the Tribal Government shall have jurisdiction over all tribal Government members and over all persons, subjects, property, and all activities occurring within its territory as defined by this Article, Tribal Government to exercise its jurisdiction, based upon its inherent sovereignty as an Tribal Government.***

## 1.4.2. ARTICLE II – MEMBERSHIP

### 1.4.2.1. Section 1. Requirements.

*The membership of the Tribal Government shall consist of:*

*(a) All persons whose names appear on the official federal acknowledgment roll prepared by Chief Head, and its supplements dated [2020].*

*(b) All persons who meet all of the Chief Head following requirements:*

*(1) has showed his/hers service to provide support applying governing member*

*(2) applies for membership in the Tribal Government, in accordance with the applicable enrolment.*

### 1.4.2.2. Section 2. Adoption into Membership.

*The Tribal Chief Head shall have sole and exclusive discretionary authority to adopt other persons as members of the Government, Provided, that at least Three (3) members of the Tribal Government vote in favour of the adoption and, Provided, That all persons adopted into membership under this section shall meet at a minimum all of the following requirements:*

*(a) at least Chief Head support of this constitution shall govern ;*

*(b) resident of the territory of the Tribe for at least one (1) continuous years;*

*(c) is a Tribal Government member of this Constitution member tribe; and*

*(d) applies for membership in accordance with the applicable open enrolment by the Chief Head*

### 1.4.2.3. Section 3. Rights of Members.

*All persons accepted as members under Section 1, above, or adopted into membership under Section 2, above, shall have the same rights as tribal members in accordance with this constitution, Provided, That the Chief Tribal Government may give preference to the territory of the Government for available land, housing, benefits, and services.*

### 1.4.2.4. Section 5. Reinstatement.

*Any person who relinquishes his or her*

*(a) at least requirement noted by the Chief Head have passed since the date of their relinquishment or dis enrolment;*

*(1) This five (5) year waiting period for reinstatement shall not apply to persons who were under the age of eighteen (18) at the time of their relinquishment or dis enrolment.*

*(2) This five (5) year waiting period for reinstatement shall not apply to any person whose relinquishment or dis enrolment occurred prior to the adoption of this constitution.*



- (b) provides adequate proof to the Chief Head and or Tribal Government Member that he or she has given up his or her membership in any other federally recognized Indian Tribe, band or group; and*
- (c) applies for reinstatement as a member of the Tribe, in with the applicable enrolment application.*

#### **1.4.2.5. Section 6. Appeal.**

*Any person whose application for enrolment or reinstatement is rejected or who has been disenrolled from the Tribe, shall have the right to appeal to the Tribal Court in accordance with the applicable open enrolment, Provided, That the Chief Justice shall have jurisdiction over adoptions of persons as Government members.*

#### **1.4.2.6. Section 7. Membership Roll.**

*The Tribal Government Member shall maintain a membership roll of all current and former tribal members. Open Enrolment Application. The Tribal Government Member shall enact an Open enrolment Application consistent with this constitution.*

### **1.4.3. ARTICLE III – ORGANIZATION OF THE GOVERNMENT**

*The Tribal government of the federal Land Management of Mendocino Indian Reservation shall include a Tribal Nations Government, a Tribal Government Court System, and a Tribal Government Administration. The Tribal Nations Government shall operate in accordance with The Tribal Court System shall operate in accordance with The Tribal Government Administration shall be subordinate to the Tribal Nations Government Federal Land Management of Mendocino Indian Reservation.*



## 1.4.4. ARTICLE IV – THE CHIEF TRIBAL GOVERNMENT

### 1.4.4.1. Section 1. The Tribal Government.

The Tribal Government governing body Chief Head of the Federal Land Management of Mendocino Indian Reservation the Tribal Government shall be known as the “Tribal Government “Federal Land Management of Mendocino Indian Reservation Chief Head which shall consist of three (3) members as listed in this Article. All Tribal Government Members shall be Approved members selected by the Chief Head eligible of the Tribal Government in accordance with this constitution Quorum (3) members.

### 1.1.1.1. Section 2. Chief Head .

The Tribal Nations Chief Head shall include the positions of Chief Branch who must reside within the within Republic of California the territory of the Tribal Government, and who must at least be Fifty one (51) years of age.

### 1.1.1.2. Section 3. Area Government Members.

The Tribal Government shall also include.

- (1) Area Government Members: one person who reside in the northern Mendocino area and two
- (2) persons who reside in the southern Los Angeles area. Regardless of any other law, treaty or agreement which may define the Tribe's territory, by Chief Heads. The Tribal Government may include in the defined areas any land that is within the territory of the Tribal Government or within the territory. Although the Area Chief Head Tribal Government Members must reside in their respective areas as defined by the Tribal Government pursuant to this Section, the Area Tribal Government Members.







## **ARTICLE V – Federal Land Management of Mendocino Indian Reservation Tribal Government**

### **1.1.1.3. Section 1.**

#### **Government Chief Head Member.**

*The Tribal Government shall also include one (1) President Member (1) Vice President who must reside within the territory of the Tribal Government or the territory of Office, and who must be at least Thirty-Five (35) years of age.*

### **1.1.1.4. Section 2.**

#### **Terms of Office.**

*The terms of office for all Chief Head Tribal Government Members including the President and Vice President shall be four (4) years.,*

### **1.1.1.5. Section 3.**

*There shall be serving consecutive terms on the Tribal Government. All Tribal Government Members must continue to meet the requirements set forth above for their respective Tribal Government seats during their term of office.*

### **1.1.1.6. Section 4. Duties of the Officers.**

*The duties of the President and Vice President shall be established by Law enacted by the Tribal Government Constitution.*

### **1.1.1.7. Section 5. Meetings Tribal Government.**

*(a) The Tribal Government shall hold a regular meeting once a month.*

*(b) The President of the Tribal Government may call special meetings of the Tribal Government. Adequate notice of all special meetings shall be given to all members of the Tribal Government.*

*(c) At each regular or special meetings of the Tribal Government shall be appointed to take minutes of the meeting, and a copy of the minutes shall be preserved by the Tribal Administration.*

### **1.1.1.8. Section 6. Quorum.**

*Tribal Government Chief Head and two (2) or more members of the Tribal Government shall constitute a quorum of Three (3) for any regular or special Tribal Government meeting. This quorum is required at all meetings to conduct official business of the Tribal Government.*



#### **1.1.1.9. Section 7. Voting.**

***The Tribal Government shall make decisions by a majority vote of those present except as otherwise provided in this constitution requires the Chief Head President and , Vice President shall have the power to vote.***

#### **1.1.1.10. Section 8. Code of Ethics.**

***The Tribal Government shall have the power to adopt the conduct of tribal Government officials. may include disciplinary procedures so long as the official in question is informed of the charges and given an opportunity to respond to those charges including the opportunity to present witnesses and other evidence in his or her defence.***



## 1.1.2. ARTICLE VI - POWERS OF THE TRIBAL GOVERNMENT

***The “Chief Justice” shall have all powers vested in the Tribal Government through its inherent sovereignty by Chief Head federal law. It shall execute these powers in accordance with established customs of the Tribal Government and subject to the express limitations contained in this constitution or other applicable laws. These powers include but are not limited to the following:***

- (a) To represent the Tribal Government and act in all matters that concern the welfare of the Tribal Government, and to make decisions to this constitution.***
- (b) To negotiate and enter into contracts with the federal, state, local governments, and with individuals, associations, corporations, enterprises or organizations.***
- (c) To purchase or accept any land or property for the Tribal Government.***
- (d) To enact laws regulating the use, inheritance of all property within the territory of the Tribal Government.***
- (e) To lands interests in tribal funds or other tribal assets;***
- (f) To employ accordance with applicable Tribal Government laws;***
- (g) To enact Tribal Government laws regulating the domestic relations of persons within the jurisdiction of the Tribal Government:***
  - (h) To enact a law-and-order Tribal governing the conduct of constitution within the laws;***
  - (i) To provide for the exclusion of any non-member***
  - (j) To levy and collect taxes, duties, fees and assessments.***
  - (k) To appropriate and regulate the use of funds in accordance with an annual budget approved by the Tribal Government;***
  - (l) To regulate all business activities within the jurisdiction, and to manage all economic affairs and enterprises.***
  - (m) To regulate all matters and to take all actions necessary to preserve and safeguard the health, safety, welfare;***
  - (n) To appoint Tribal Advisory Committee, Tribal Business Department. Administration, Representatives and, Tribal Government Tribal law enforcement officers and Security, and to set their compensation, tenure and duties.***
  - (o) To enact laws, necessary or incidental to the exercise of its Tribal Government powers;***
  - (p) To take any and all actions necessary and proper for the exercise of the foregoing powers and duties, including those powers and duties, and for all other powers and duties now or hereafter delegated to the Tribal Government, or vested in the Chief Justice by federal law or through its inherent sovereignty.***



### 1.1.3. ARTICLE VII - THE TRIBAL GOVERNMENT SYSTEM

#### 1.1.3.1. Section 1. Establishment.

*The judicial power of the Tribal Government Tribal Nations Federal Land Management of Mendocino Indian Reservation Chief Justice shall be vested in the Tribal Government Court System. The Tribal Government Court System shall include a Tribal Government Court System Chief Justice and such other lower Tribal Government Tribal Law enforcement of special jurisdiction, including forums for traditional dispute Document, as the Tribal Government Court system may establish by this constitution. There shall also be a Tribal Government System Court of Appeals which shall be the court of last resort for all cases filed within the Chief Justice Tribal Government Court System.*

#### 1.1.3.2. Section 2. Jurisdiction.

*The judicial power of the Tribal Government courts System shall extend to all cases and controversies within the jurisdiction of the Tribal Government arising under this constitution, the laws enforced or customs of the Tribal Government or which are vested in the tribal Government by federal law or by virtue of the Tribe's Government inherent sovereignty. Any case or controversy arising within the jurisdiction of the Chief Justice shall be filed in the Tribal Government Court appropriate forum established by the Chief Head before it is filed in any other court.*

#### 1.1.3.3. Section 3. Appointment of Chief Justice.

*The Tribal Government Chief Justice to serve for a term of (Life). There shall be one Chief Justice for the Tribal Government.*

#### 1.1.3.4. Section 4. Qualifications of Judges.

*The qualifications for Chief Justice shall be established by Chief Head , Provided, that no additional requirements may be added during the tenure of already in office,*

#### 1.1.3.5. Section 5. Compensation.

*Chief Justice shall receive for their services reasonable compensation that shall not be diminished during their term of office.*

#### 1.1.3.6. Section 7. Court Rules.

*The duties and procedures of the Tribal Government Court System, and all other court matters not addressed in this article of the constitution, shall be established by the Chief Justice, Chief Geronimo Thomas Langenderfer Tribal Government Court System to this constitution.*





#### **1.1.4. ARTICLE VIII - THE TRIBAL ADMINISTRATION**

*The Tribal Administration shall consist of the Chief Head and President of the Tribal Government, and other persons as deemed necessary by the Tribal Government. The Tribal Administration shall oversee the administration of the tribal Government business and shall supervise the day-to-day operations of the Tribe. The Tribal Administration shall be subordinate to the Tribal Government.*

#### **1.1.5. ARTICLE IX - ELECTIONS**

##### **1.1.5.1. Section 1. General Elections.**

*General elections to vote for Tribal Government Members shall be Election of Tribal Government Members seats shall be up for election 4 year term..*

##### **1.1.5.2. Section 2. Special Elections.**

*Special elections shall be held when called for by the Tribal Government, by this constitution, or by the Tribal Government, as provided for in this constitution...*

##### **1.1.5.3. Section 3. Qualifications for Tribal Government.**

*Persons nominated to run for Tribal Government seats must be enrolled Tribal Government members who meet the age requirements set forth by the Chief Head on or before the date of the election, and they must meet the residency requirements set forth in for at least one year to the date of the election*

##### **1.1.5.4. Section 4. Oath of Office.**

*The oath of office for each newly elected Tribal Government Member shall be administered by the Chief Head within thirty (30) days after the Election declares the winner of a seat, unless a challenge is filed and in that case within thirty (30) days after a final decision by the Tribal Government Court or the oath of office shall be administered to the newly elected Tribal Government Members whose seats have not been challenged within thirty (30) days after the Tribal Government declares the winners. Each incumbent Tribal Government Member shall remain in office until the oath of office is administered to the Tribal Government Member for his or her seat her control to the newly elected Tribal Government Member.*



## **1.1.6. ARTICLE X - REMOVAL, RECALL AND VACANCY**

### **1.1.6.1. Section 1. Removal.**

*(a) The Tribal Government shall remove a Member for:*

*(1) Final conviction of a Tribal Court felony by any tribal court while serving on the Tribal Government.*

*(A) The Tribal Government may suspend a Member charged with a felony pending the outcome of the trial Tribal Government Court and any appeals.*

*(b) The Tribal Government may discipline or remove a Government Member, must convey with the Chief Head to approve vote of at least three (3) members of the Tribal Government, for:*

*(1) Converting tribal Government property or monies for personal use;*

*(2) Failing to attend four (4) regular or special meetings consecutively without good cause;*

*(3) Final conviction of three misdemeanors by any tribal Government court while serving on the Tribal Government;*

### **1.1.6.2. Section 2. Vacancies.**

*(a) If a Tribal Government Member should die, resign, or be removed or recalled from office, the Tribal Government shall declare the position vacant. The Tribal Government shall fill a vacancy by special election unless less than six (6) months remain in the term, in which case the Tribal Government shall leave the position vacant. The person who fills a vacant position shall only serve out the term of the person whom he or she is replacing.*

*(b) All resignations from the Chief Head Tribal Government shall be done in By application.*

## **1.1.7. ARTICLE XI – LAND**

*The Chief Head Tribal Government shall have the authority to establish land policies, adopt a land use and to otherwise regulate land within the territory of the Tribe Government in accordance with this constitutional law.*



## **1.1.8. ARTICLE XII - ORDINANCES AND DOCUMENTS**

### **1.1.8.1. Section 1. Tribal Government.**

*All final decisions on matters of temporary interest where a formal expression is needed shall be embodied in a Tribal Government, noted in this Documents, and shall be available for inspection by members of the Tribal Government during normal business hours.*

### **1.1.8.2. Section 2. Ordinances.**

*All final decisions on matters of permanent interest shall be embodied in Tribal Government. Such enactments shall be available for inspection by members of the Tribal Government during normal business hours.*

## **1.1.9. ARTICLE XIII - SOVEREIGN IMMUNITY**

*Chief Head Tribal Government shall be immune from suit except to the extent that the Chief Head and Tribal Government expressly waives the Tribal Government sovereign immunity, as provided by this constitution.*

## **1.1.10. ARTICLE XV - BILL OF RIGHTS**

*Chief Head Tribal Government, in exercising its powers of self-government shall:*

- (a) make or enforce any law prohibiting the free exercise of Tribal Government, or abridging the freedom of Tribal government, the right of the peaceably to assemble.*
- (b) Have the right of the Tribal Government to be secure in their Tribal Government, Projects, Documents, and, Tribal Government shall issue warrants, but upon probable cause, supported by Tribal government Head Chief affirmation, and particularly describing the place to be searched and person or thing to be seized;*
- (c) Shall not subject any person for the same offense to be twice put in jeopardy.*
- (d) Shall not compel any person in any criminal case to be a witness against himself;*
- (e) take any property without just cause .*
- (f) Shall not deny to any person in a criminal proceeding the right to a speedy Tribal Government Court Judgement, to be informed of the nature and cause of the accusation, to be confronted with the witnesses against him, to have process for obtaining witnesses in his favour, and at his own expense*



### 1.1.11. ARTICLE XVI GENERAL MEETINGS

*The Tribal Government shall call at least one (1) general meeting per year of all the eligible voters of the Tribal Government to identify and discuss important tribal Government matters.*

### 1.1.12. ARTICLE XVII - AMENDMENTS

*This constitution may be amended by Tribal Government of the qualified voters of the Tribal Government election called for that purpose by Federal Contractor, shall become effective on the issuance of Mendocino Indian Reservation 1856 approved by the Department of the Interior Stamp attached Tribal Contractor amendment Reservation attached to this constitution and deemed approved constitution may 2020 by the Chief Head Federal Land Management of Mendocino Indian Reservation shall be the duty of this constitution proposed amendment and adopting the Tribal Government at the request of the Chief Head, enactment signed Constitution by Tribal Contractor, Chief Head, Tribal Government President and Vice President.*

### 1.1.13. ARTICLE XVIII - SAVINGS CLAUSE

*1360 (b) All enactments of the Chief's Head effective date of this constitution shall continue in full force, .*

### 1.1.14. ARTICLE XIX - ADOPTION OF CONSTITUTION

*This constitution, enacted by Tribal Federal Contractor to Chief Head of the registered of the Federal Land Management of Mendocino Indian Reservation, Tribal Government, in accordance with Chief Head Tribal Government Constitutions, shall be amended Tribal Government members to operation of law, shall be effective from the date of such approval. 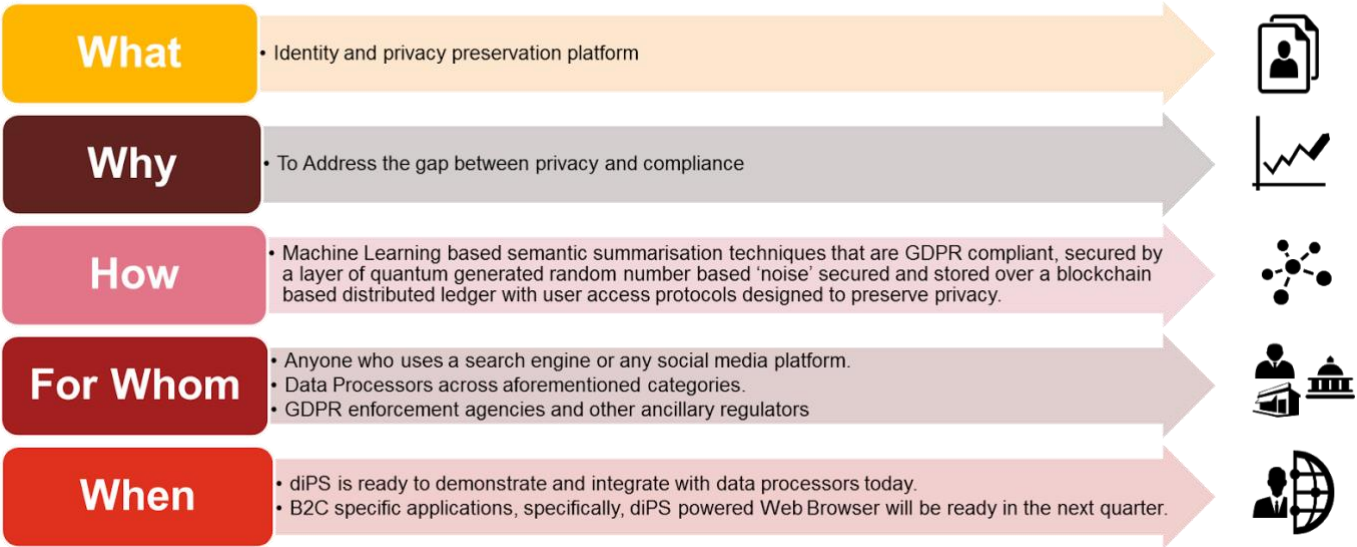

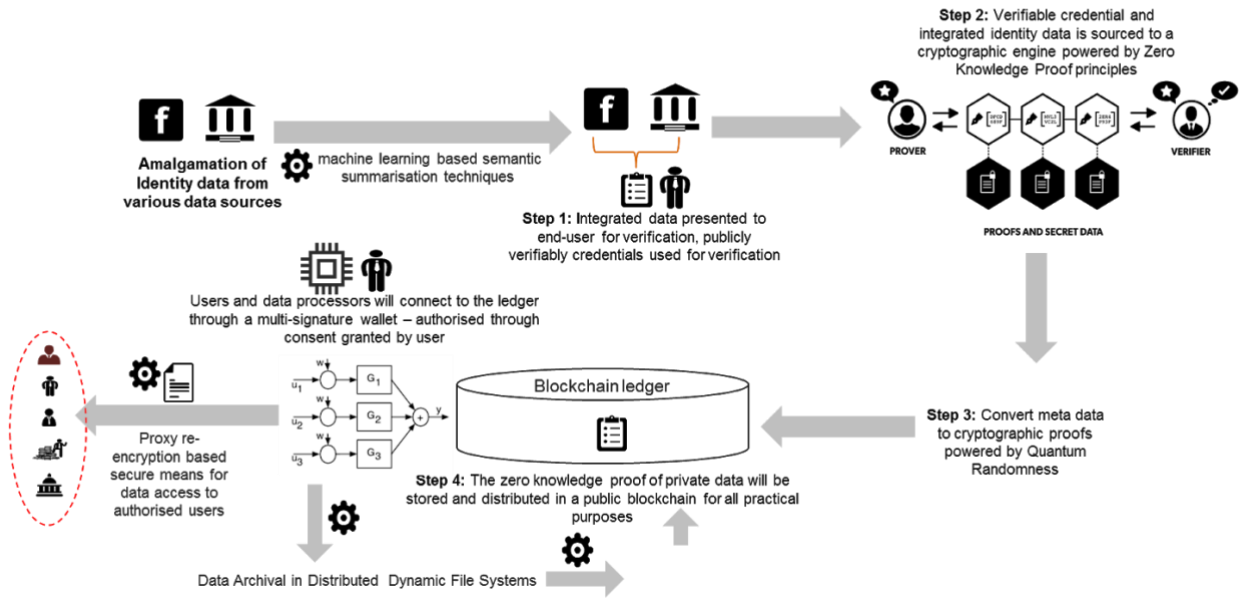

*WHEREAS, Article IV Paragraph 4 of the constitution of the United States, State shall guarantee to serve State Tribal Government Sovereignty United States of The Tribal Nations, Federal Government Nations To Nations, Yuma/ Mendocino Republic California Form Government,” and the Ninth Amendment to the constitution of the United States States that “The enumeration in the constitution, of certain rights, shall not be construed to deny or disparage others retained by the General Native People”; and*

*WHEREAS, The United States Supreme Court ruled in New York v. United States, 505 U.S. 144 (1992), that Congress may not simply commandeer the legislative and regulatory processes of the State by complying them to enact and enforce regulatory programs; and*

“25 CFR 11.104” Tribal Government law

The [Tribal Law and Order Act of 2010](#) is a law, signed into effect by President Barack Obama, that expands the punitive abilities of tribal courts across the nation. The law allows tribal courts operating in Indian country to increase jail sentences handed down in criminal cases over Indian offenders. This was a major step toward improving enforcement and justice in Indian country—and a precursor to VAWA 2013. The purposes of the Tribal Law and Order Act are to:

ify the responsibilities of the federal, state, tribal, and local governments with  
pect to crimes in Indian Country;

rease coordination and communication among federal, state, tribal, and local law  
forcement agencies;

power tribal governments with the authority, resources, and information necessary  
safely and effectively provide public safety in Indian Country;
