#### SITE NARRATIVE

All sites will be on the Mendocino Indian Reservation, although housing will not be limited to Native American veterans. Each veteran will have a private bedroom and private bathroom and the living space will meet if not exceed the requirements of this Grant.

In addition to frail veterans, we will serve women veterans, then veterans with dependents, then if space is available, veterans without special needs.

#### **HMS**

We will participate with the HMS to maximize our efficiency and services.

#### APPLICATION DESIGN

We will accomplish the following objectives. First and foremost, we will become an active member of the Lake County Continuum of Care (LCCOC) because we realize that no single organization can reduce the amount of homelessness in any meaningful way given the plethora of factors which contribute to homelessness.

LCCOC is a continuum of care (COC) for organizations serving homeless people and provides excellent resources with which to interact with those organizations. We want to make the wheel more efficient rather than reinvent the wheel.

Using our membership in LCCOC, we will solicit the assistance of other homeless programs and shelters

to help us to identify veterans who meet the definition of special needs as well as registering with veterans hotlines and other agencies that service veterans. In addition, we will make routine visits to areas where homeless people congregate. Currently, we rely on church fellowship halls and community members with unused bedrooms to help us provide for the homeless people we service. The grant will enable us to provide not only for special needs veterans but also other homeless veterans and to change the revolving door to a permanent residence.

#### 99!6nMxKWsFWDhh

VA announces the availability of approximately \$5 million per year for three years in new special need grants to eligible entities for per diem payments to facilitate housing stabilization for Veterans who are homeless or at risk of becoming homeless and who are in one of the special need populations (i.e., chronically mentally ill, frail elderly, individuals who have care of minor dependents, terminally ill or women). This funding will provide assistance to cover operational costs including costs that would not otherwise be incurred, but for the fact that the recipient is providing supportive housing beds in private rooms with private bathrooms for a homeless Veteran population with special needs. VA expects to award per diem for approximately 135 beds across approximately 10-15 grants with this Notice of Funding Opportunity (NOFO).

Each application must include a minimum of five special need beds and up to a maximum of 10 special need beds per VA medical facility catchment area, per each applicant's Employer Identification Number (EIN). Each application must propose to serve one special need population. The various special needs populations are defined in 38 CFR 61.1 and are summarized in this NOFO.

Each applicant may request the lesser of one hundred percent of the daily cost of care for furnishing services to homeless Veterans with special needs; or two times the current VA State Home Program per diem rate for domiciliary care as set by the Secretary under 38 United States Code (U.S.C.) 2012 and 38 U.S.C. 1741(a)(1), which at the time of this NOFO publication would be two times \$49.91 per day as shown on the GPD program website at: www.va.gov/homeless/gpd.asp. The per diem payment calculation may be found at 38 CFR 61.33. The maximum amount of per diem requested must not exceed the cost of care or \$1,100,000 total costs for the entire three-year grant period, whichever is less, based on variables such as the average number of beds to be provided as stated in the grant application and the current per diem rate maximum. Applicants may request no more than the cost of care or \$110,000 total costs per bed over the entire three-year grant period, whichever is less, based on variables such as the average number of beds to be provided as stated in the grant application and the current per diem rate maximum.

The special need beds supported under this grant must be in private rooms with private bathrooms including the following characteristics:

- 1. The minimum square footage for the private bedroom and private bathroom combined is 120 square feet. The bedroom and bathroom do not need to be attached, in which case the walkway would not usually count toward the square footage calculation.
- 2. The bathroom must include shower and/or tub, sink and toilet.
- 3. Neither the bedroom nor the bathroom facilities may be shared (e.g., no shared sink area outside the toilet room).
- 4. Rooms with partial walls are not acceptable. Walls must go floor-to-ceiling. Rooms must have a door and not involve unauthorized passage through another dwelling unit.

We will insure that all veterans present us with a DD214 which we will assist them in getting. In emergencies, we will accept a VA identification card or some other proof that they have received healthcare through the VA. GPD grant assistance will enable us to expand our services by providing a fixed place of residence for homeless veterans and by using community resources, help those veterans to transition to permanent housing. We have the land to erect permanent energy efficient housing on which we can help veterans realize the American dream of home ownership. The GPD grant will enable us to provide not only housing, but other services needed to assist veterans transition to permanent housing.

#### NEED

In the Committee Report to the "Ending Homelessness Act of 2019," Congress declared the critical need for increased funding to deal with the United States' homelessness crisis:

The Congress finds that--

- (1) although the United States has experienced a reduction in veteran homelessness after a surge of new Federal funding targeted to homeless veterans starting in fiscal year 2008, major progress towards the national goals for ending homelessness in our Nation has virtually stalled in the absence of increased funding;
- (2) according to the Department of Housing and Urban Development's 2018 point-in-time count, there were 552,830 people experiencing homelessness in the United States on any given night, including nearly 160,000 children and youth;
- (3) homelessness in many communities has reached crisis proportions and some cities have declared that homelessness has

reached a state of emergency; and

(4) the Federal Government must renew its commitment to the national goals to end homelessness.

The problem of veteran homelessness persists. We declare that not a single veteran should be homeless and sleeping under bridges, in alleys, or in empty and abandoned buildings. According to the Veterans Administration ("VA"), "The most recent PIT [Point-in-Time] Count was conducted in January 2018. This national snapshot of Veteran homelessness showed that:"

On a single night in January 2018, just over 37,800 Veterans were experiencing homelessness.

On the same night, just over 23,300 of the Veterans counted were unsheltered or living on the street.

And while the VA notes a decrease in homelessness among veterans between 2017 and 2018, the matter is still considered a crisis, id. In the eyes of our organization, even one homeless veteran is too many. Hence, the need for continuing to work hard and increase funding sources to combat homelessness among those who "··· shall have borne the battle and for his widow, and his orphan." We seek to do just that in this grant proposal.

#### SPECIAL NEED

We have been involved in homelessness for many years so we are well aware of the persisting problem. The United Veterans Council of Lake County has noted the need for for shelters for particular groups of peoples with special needs
(https://www.uvclc.org/lake-county-help/shelters/). The LCCOC notes that Lake County
has the second lowest rate of home ownership in California
(https://www.lakecoc.org/housing-fact-sheet). It notes further that "About one in ten
Lake County public school children are homeless, more than double the state rate of 4%.
and higher than neighboring counties." Further, "Total homeless population in Lake
County, [is]enough to fill about 50 school buses and about the same as the population
of Kelseyville." Finally, the COC advises that "Average annual cost to taxpayers for a
chronically homeless person can be reduced by about 50% when homeless individuals
are placed in supportive housing." (Source: National Alliance to End Homelessness.)
The GPD grant will enable us to provide that supportive housing for veterans with
special needs given that our survey did not reveal an existing homelessness program
designed specifically for veterans.

#### PROJECT PLAN

We will offer and coordinate a host of services that address the needs of each homeless person.

These services include:

- 1. To help the hopeless feel loved and accepted.
- 2. To provide continuing education through recreation, crafts, academics, and indigenous self-leadership

development.

- 3. To open paths for the community to participate more regularly in meaningful, productive activities.
- 4. To discover resources and skills for solving personal and interpersonal problems.
- 5. To discover academic success through educational therapy skill builders that will promote self-esteem

in our community as well as offer tutorial assistance where needed.

- 6. To discover role models within the community, city, state, and nation.
- 7. To discover pride and awareness in each person's heritage.
- 8. To implement mentoring projects, retreats, cultivation of arts and humanities by participation in art

festivals and similar endeavors.

We will use the definition of veteran contained in 38 CFR 61.41 and we will require a DD214 to ensure

eligibility. We will assist in the acquisition of the DD214. We will also use the definitions contained in 38

CFR 61.41 to identify frail veterans, women veterans, and veterans with dependents.

Services will be provided as regularly as needed. However, each veteran who is able, must attend a job

search activity at least three times a week and housing counseling at least once a week. Those who

reveal trouble with addiction will be required to attend weekly therapy sessions. We will provide

transportation to and from all activities as well as medical appointments. We will use existing resources

such as employment services, housing counseling services for our veterans.

We will have a part-time

dietician for meal planning, especially those whose condition or preference require special diets.

Ordinarily we would not be offering employment, permanent housing activities, and meal planning as

regular activities which are now needed for the special needs veterans we hope to be serving. All

persons associated with our activities and services will be required to meet the minimum qualifications

of their profession or craft.

In summary, we offer Housing, Housing Community Services connections, resume writing/Interview

practice, budgeting, and Christian education. Using professional personnel that are trained and skilled in

the above areas of concerns. In addition, we provide teachers/life skill coaches, business office/training

center networking with like minded organizations in the community. We also provide procedures and

processes ensuring we are maintaining the rules and guidance dedicated by our State concerning

Covid-19 requirements for our daily operations in the home as well as the office.

#### **PROJECT PLAN**

Previously, we have provided housing services to whoever contacted us. Now, with the GPD grant, we will seek out veterans with special needs as defined in the requirements for the GPD. We will use the standard definition for homelessness and will screen each veteran to make sure we can accommodate and serve the needs of that particular veteran. Particular attention will be paid to frail veterans to make sure we can serve their needs and if not, we will seek placement in a VA facility or appropriate private facility.

#### PROJECT PLAN

We will employ a Veterans Coordinator who will develop an ISP for each veteran in conjunction with a RN and dietician. We will use an appropriate computer-based monitoring system to maintain data on each veteran as well as services provided, when

and by whom. The Program Director will review these notes from time to time to assess the progress of each veteran and will hold weekly review sessions with the Veterans Coordinator, RN and dietician to monitor the progress of each veteran and make any changes needed to keep the veteran moving forward.

## PROJECT PLAN

We will provide policies to prohibit the use of alcohol and illicit drugs on site and during any of our programs. Smoking will be allowed only in designated areas. Violators will be given additional attention and treatment if needed. Discharge will be a last resort reserved for the most egregious and persistent violator. After all, our mission is to assist veterans to recognize and to overcome those factors which have contributed to their homelessness.

#### PROJECT PLAN

All of the services we are offering are because of the GPD grant because previously we were mostly a referral agency, though we did at times provide funds for a few nights in a motel for a homeless person when we could not find an available bed in a shelter. We will work with local agencies and organizations to develop a plan for transitioning veterans to permanent housing. For the frail veteran, we will strive to get them into assisted living facilities, including VA aged homes. We will be seeking additional funding to build energy efficient, environmentally friendly homes on our Reservation to house veterans where they can have a community garden to grow some

of their own fruits and vegetables. We anticipate a timeline of six to nine months to transition a veteran from homelessness to permanent housing.

#### **OUTREACH**

To reach our goals. we will become an active member of LCCOC. We realize that no single organization can reduce the amount of homelessness in any meaningful way given the plethora of

factors which contribute to homelessness. LCCOC is a continuum of care (COC) for organizations

serving homeless people and provides excellent resources with which to interact with those organizations.

Another reason why joining LCCOC is critical is because of the need to modify how homelessness is

counted. Those in transitional and stable housing should no longer be counted among the homeless.
